

Privacy Policy

Welcome to Bonanza Portfolio Limited. The domain name www.bonanzaonline.com (hereinafter referred to as "Website") is owned by Bonanza Portfolio Limited, a company incorporated under the Companies Act, 1956 having its registered office at **Bonanza** House, Plot No. M-2, Cama Industrial Estate, Walbhat Road, Behind the Hub, Goregaon (East), Mumbai, Maharashtra 400063 (hereinafter to be referred as "BONANZA PORTFOLIO LIMITED").

For the purpose of this Privacy Policy, wherever the context so requires the term "You" or "User" shall mean any natural or legal person including Online and offline clients and the term "We", "Us", "Our" shall mean Bonanza Portfolio Limited.
