The Benchmark index witnessed a Flat Opening on 15/10/25 but remain on sideways to higher side through out the day as after initial gain some profit booking & long unwinding seen after Exchange hike marginal requirement, but in evening after fall in dollar index & technical support zone again lower level buying seen on continue to safe haven after fresh tariff threat by U.S President over China added by strong ETF inflows along with technical bullish trend all support bullion and which all resulted in index close near days high and well above over previous day close.

Now, Index has Support 29800-300-28500-100-27800-400-200-27000-26600-300-25800-500-250-24900-750-500-300-23900-23650-400-200-23000-22750-400-100-21800 as long hold, more upside expected towards 30400-30500 in short term. Other side only Sustain below 21800 seen 21350-21000 / Dn rally in days to come.

Price is trading above short term 13-days SMA and RSI at 90 mark with Upside slope indicates more room for higher side in the counter. Other side above zero line MACD seen buying support at every dip.

The Benchmark index seen a gap Down Opening on 15/10/25 but remain on sideways to higher side through out the on lower level buying after previous day fall back by fall in dollar index and strong fundamentals and which all resulted in index close marginally below over previous day closing.

Now index has a Support at 18350-100-17800-600-400-200-100-16950-16800-16700, as long hold, more Upside expected towards 19400-19500 in medium term. While on lower side only sustain below 16400-200 seen 16000 again in days to come.

Price is trading around short term 13 SMA while RSI at 64 marks with Flat slope indicates mix of the view in the counter. Other side slight above zero line MACD indicates more buying seen at every dip in the counter.
