- Nifty closed sharply lower (-1.01%), indicating strong profit booking from higher levels after multiple failed attempts near the recent swing highs.
- The index slipped below the 20-EMA, reflecting short-term supply pressure.
- Immediate support is placed at 25,850–25,800, aligned with the recent demand zone and 50-EMA proximity
- A decisive break below 25,800 may open room toward 25,600 (100-EMA).
- On the upside, 25,950–26,000 remains a stiff resistance; sustained reclaim above this zone is required for trend continuation.

- Bank Nifty closed marginally lower (-0.51%), indicating mild profit booking after recent breakout attempts near 60,000.
- The index continues to trade above the 20-EMA and 50-EMA, suggesting buying interest on intraday declines.
- Immediate support is seen at 59,300–59,200, aligned with the 20-EMA and prior consolidation base.
- A decisive breakdown below this zone may lead to 58,800–58,700 (50-EMA).
- On the upside, 59,900–60,000 remains a critical resistance; a sustained breakout above this level could resume the upward momentum.

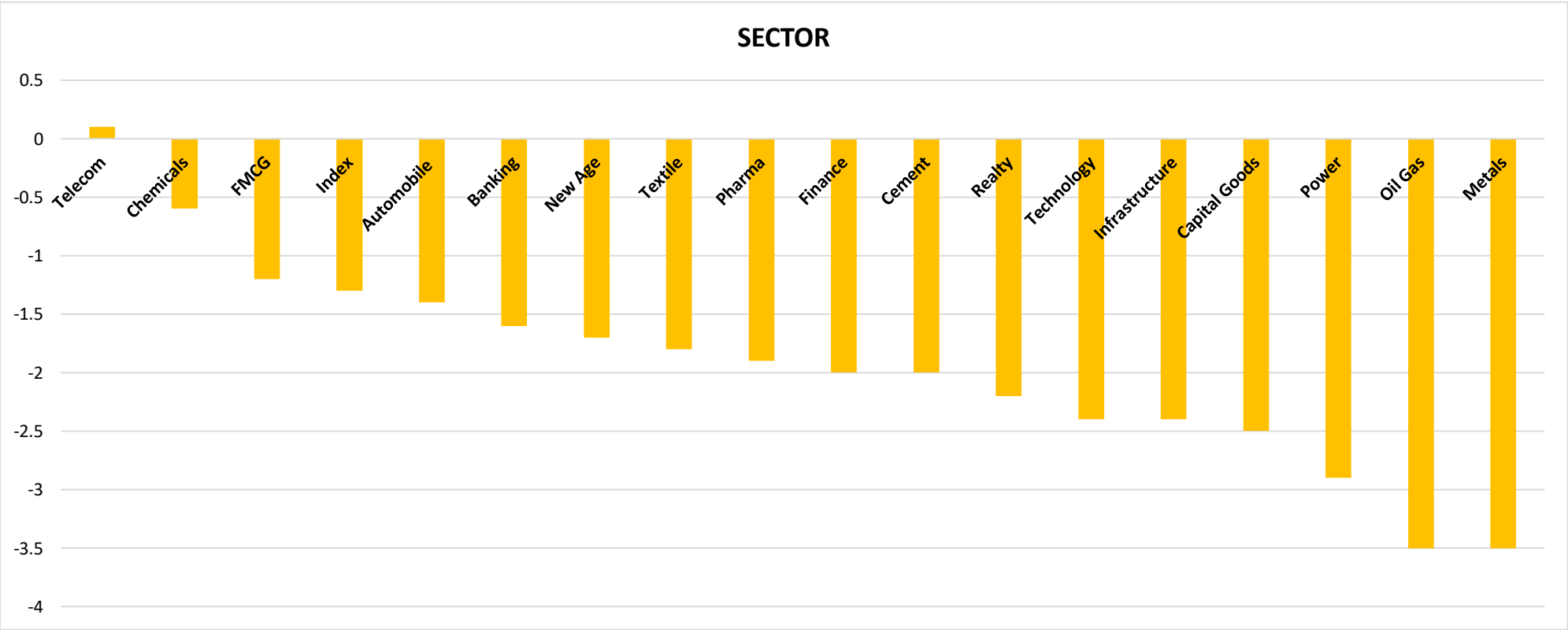
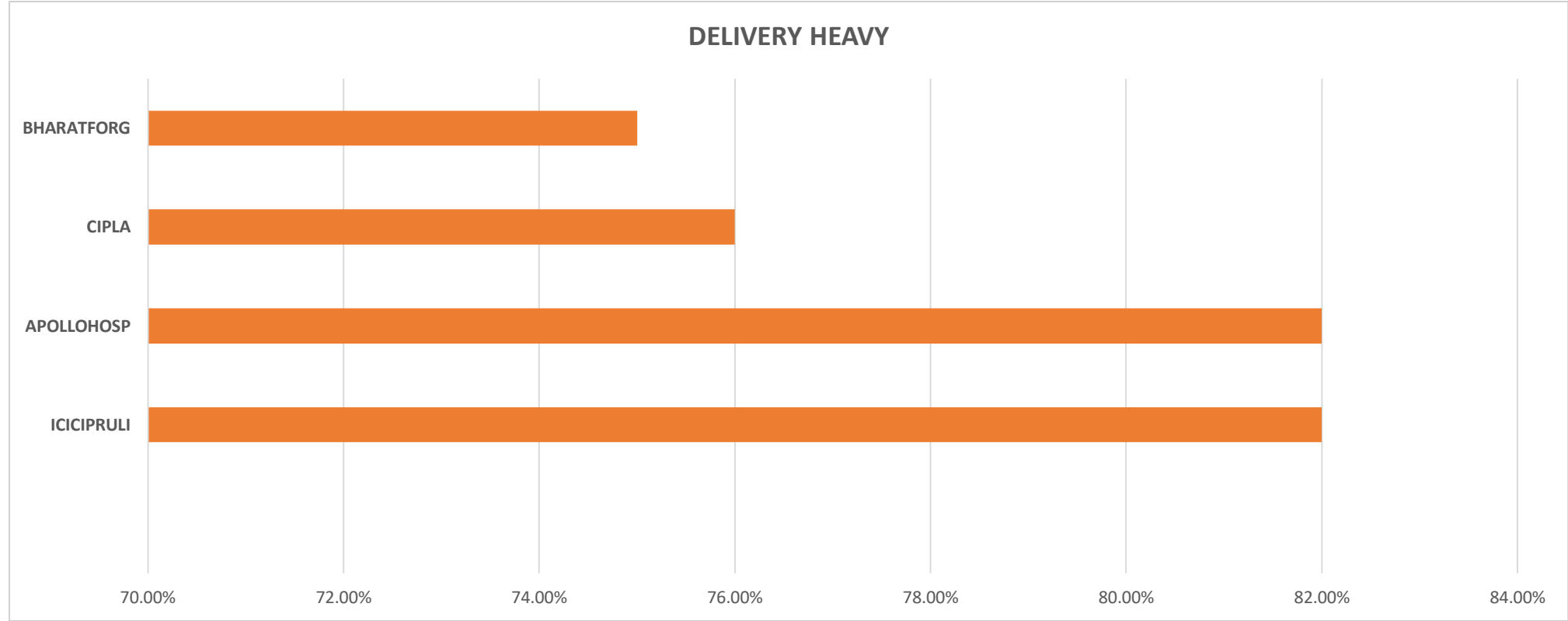

- The stock is in a clear downtrend, consistently forming lower highs and lower lows. It has recently broken an important support level, followed by a brief consolidation and another breakdown with strong volume, indicating continued selling pressure. The trend is further confirmed as the price is trading below all major EMAs of 20, 50, 100, and 200, reflecting weakness across short, medium and long-term timeframes. Momentum indicators also support the bearish view, with the RSI currently at 33.08, well below its 14-day average of 38.91.
