- Nifty has witnessed a decisive breakdown below the 25,600–25,650 support zone, which earlier acted as a key demand area and also coincided with the 20- and 50-day EMA cluster.
- The index is now testing the rising trendline support placed near 25,150–25,100, making this zone crucial from a short-term perspective.
- On the upside, immediate resistance is seen at 25,600, followed by 25,800–25,850.
- The broader trend remains positive but weakening, as prices continue to trade above the 200-day EMA (~25,160).

- Bank Nifty has broken below the key short-term support zone of 59,000–58,900, accompanied by sustained selling pressure.
- The index is now trading below its 20-day and 50-day EMA, signaling a loss of short-term momentum.
- The immediate support is placed near 58,800, followed by the rising trendline and 100-day EMA support around 58,100–58,000.
- On the upside, 59,000–59,200 will act as an immediate resistance zone.

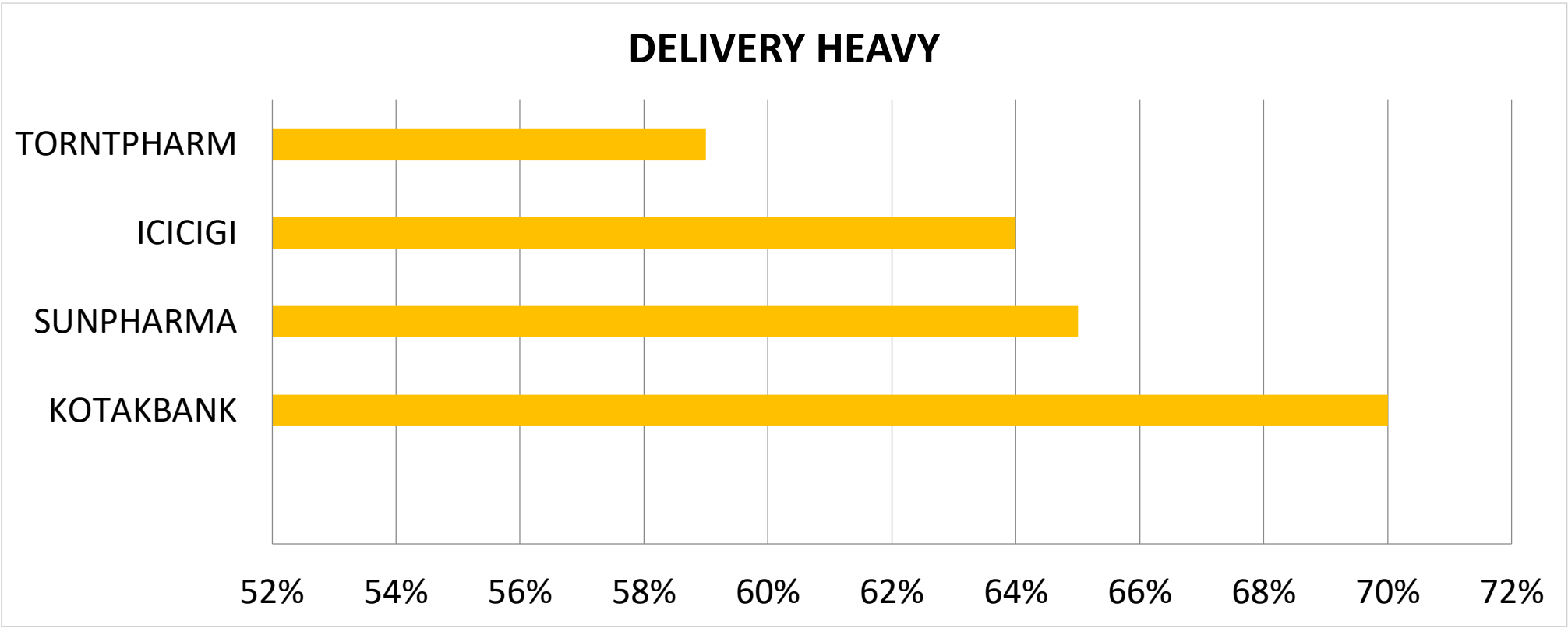
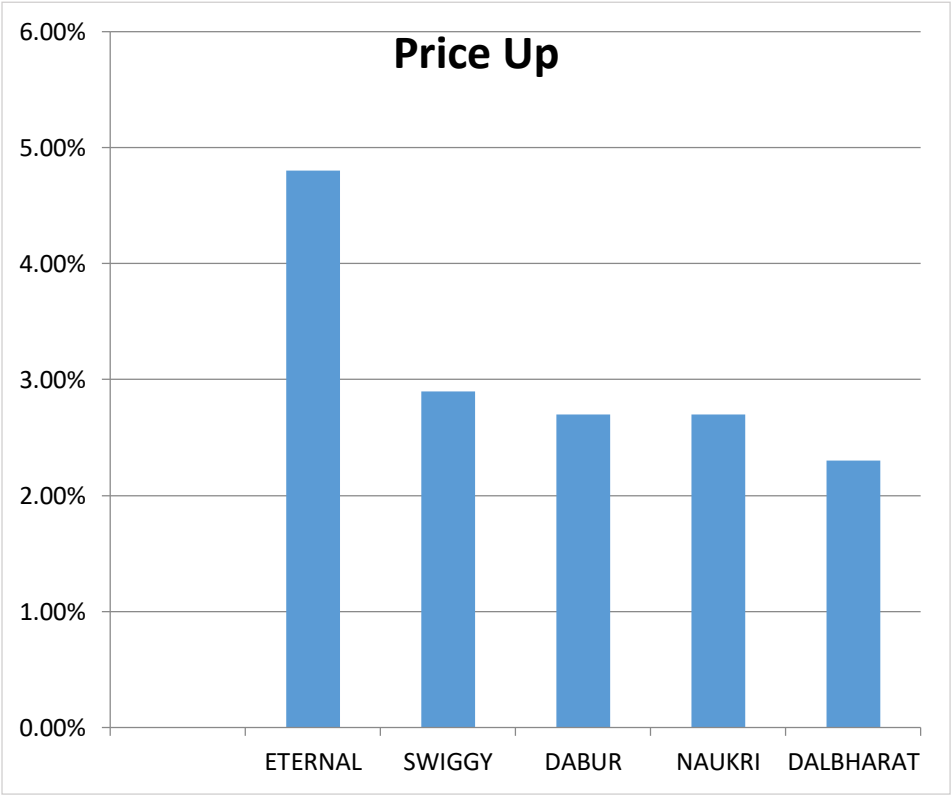

Price is below all major EMAs confirms short term and mid term bearish momentum, and RSI at 24 (below its 14-period average of 24.4) confirms strong bearish momentum.

A resistance breakout with strong volume adds confirmation. Price trading above the 20, 50, 100, and 200 EMAs supports short- to mid-term bullish momentum, while RSI at 67.58, above its 14-period average of 57.24, indicates continued buying strength.
