- Immediate resistance is seen near 26,200–26,300, while strong support lies at 25,650, followed by 25,400.






- Bank Nifty ended marginally lower (~-0.2%), reflecting indecision near the 59,200 zone after a strong prior up-move.

- Resistance is placed near 59,600–59,800, a decisive close above which can resume upside momentum toward 60,200+.




