- Nifty has witnessed sharp selling pressure from higher levels, leading to a decisive breakdown below the rising trendline support and short-term moving averages.
- The recent price action indicates a shift from consolidation to corrective phase, suggesting near-term caution.
- The index has slipped below the 20 and 50 EMA, and is now approaching the 25,150–25,000 support zone, which coincides with the 100 EMA and prior demand area.
- While this may lead to a short-term technical bounce, the broader momentum remains weak unless Nifty decisively reclaims 25,400–25,500 on a closing basis.

- Bank Nifty continues to trade within a medium-term rising channel, indicating that the broader trend remains structurally positive despite recent consolidation near higher levels.
- The index has witnessed profit booking after testing the 60,000 zone, leading to short-term sideways to corrective price action.
- On the downside, 59,000–58,900 emerges as an immediate support zone, which coincides with the 50 EMA and prior breakout area.
- On the upside, 59,800–60,000 remains a strong resistance zone.

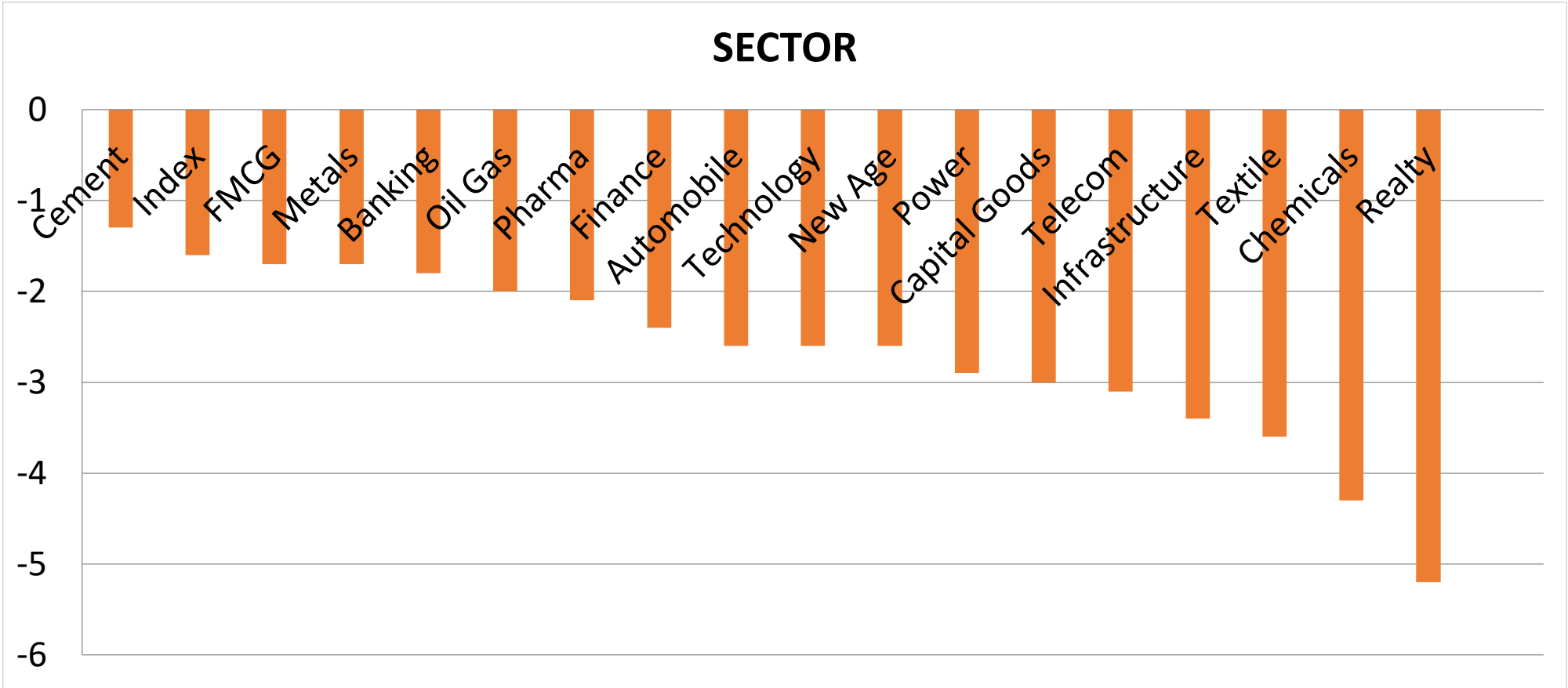
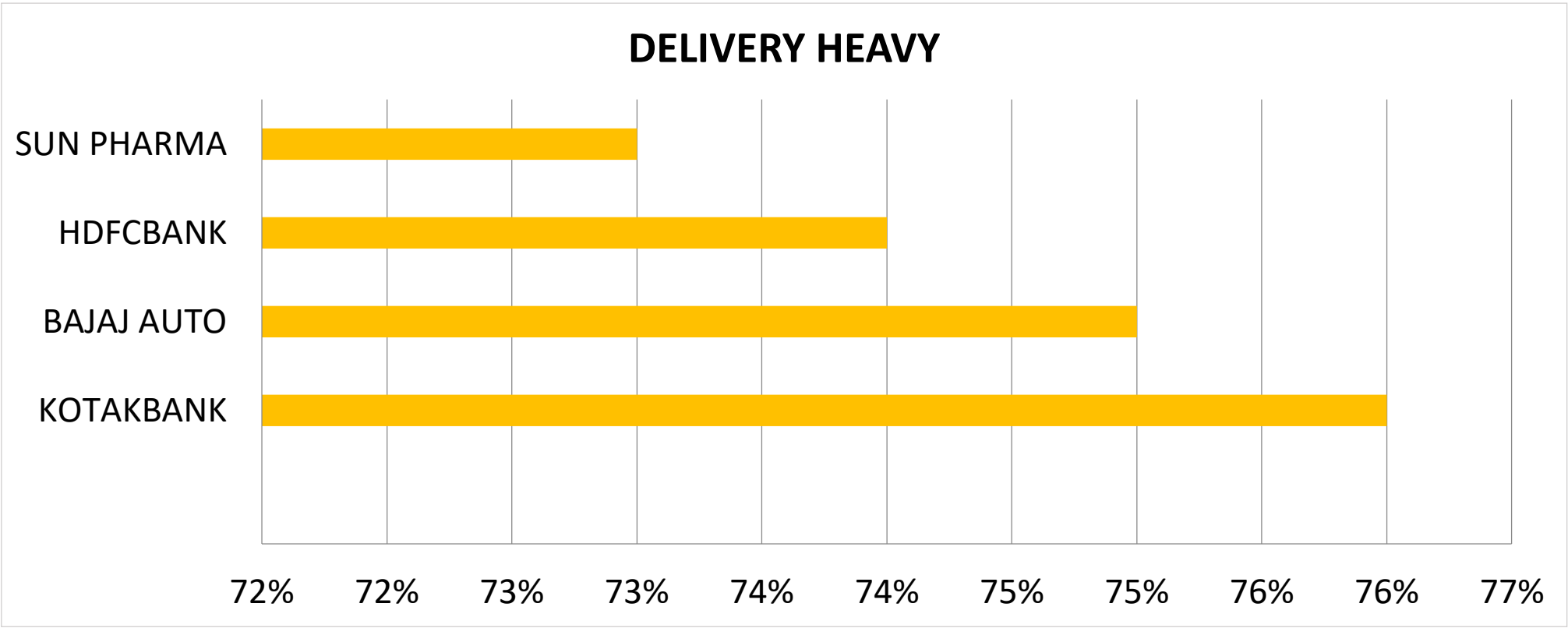
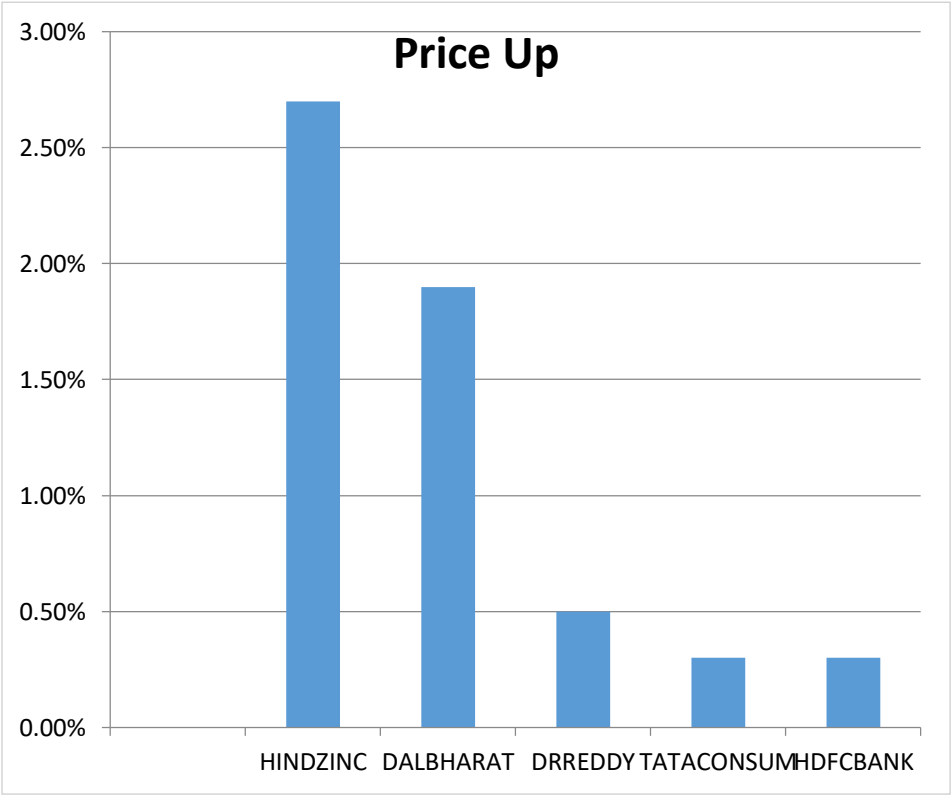
