Rationale:

- The stock has taken strong support near the 370–390 zone on the daily timeframe, indicating a solid base formation and consistent buying interest at lower levels. The presence of a rising trend line further reinforces the strength of the ongoing uptrend
- It has witnessed a decisive breakout above the key resistance zone of 400–410, backed by a strong bullish candle and a notable surge in volumes. This breakout confirms fresh accumulation and signals a continuation of the prevailing upward momentum in the near term.
- The price is trading above the 20, 50, 100, and 200-day EMAs, highlighting a well-established bullish structure across timeframes. Additionally, the RSI is hovering around 75–78 and trending upward, reflecting strong momentum, although the overbought condition may lead to some short-term consolidation before the next leg of the rally.
