

Rational:

- Coromandel has formed a Descending Triangle pattern near its top which indicates a decisive junction at current rate. The primary trend is positive, whereas the secondary trend is also positive, a shift in minor trend recently indicating a positive trend to continue in coming days.
- During the formation, the accumulation in buying and distribution in selling indicates that the buyers are keen to buy the security and are expecting more upside in the security.
- A shortfall in the formation also indicates the probability of breakout on the upside.
- A spurt in volume in current trading session is indicating rise in interest in the security.
- The price is trading above the Base line, Conversion Line and Ichimoku Cloud which indicates that the trend in the security is positive.
- The RSI is making HH and LH supporting the price action, after a week the RSI is able to close above its Exponential (9) day MA which also suggest that the trend is changing and the price are trading above the average.
- The DI+ is trading above DI- which indicates an uptrend in the security, whereas ADX trading above DI- indicates strength in the up move.
