> On daily timeframe SuvenPharma has formed a symmetric triangle breakout indicating breakout at the higher side.
> Price has taken support at moving Average EMA (200) which will act as a strong support in coming weeks. Price currently is able to trade above 50 EMA which indicates a positive trend in the security.
$>$ On the momentum RSI (14) has given a fresh breakout supporting the price action.
