## Rationale:

- A gap up opening followed by resistance breakout is visible indicating accumulation at lower levels, validating the bullish outlook and indicating potential uptrend.
- Technical Structure: RSI above 60, confirming bullish momentum and entering strength territory. Price is well above all major EMAs, which are aligned positively—strong uptrend structure.
- Volume and Candle: Recent candle is bullish bouncing back from the bottom with noticeable rise in volume, suggesting fresh participation & buying indicating conviction after breakout.
- Renewed Buying: The breakout from a consolidation zone with pattern in play signals renewed buying interest, possibly triggering momentum-based follow-up buying in upcoming weeks.
