

# **WEEKLY FOREX INSIGHT**

**DATE: 18-3-2024** 

#### **KEY HEADLINE**

The Indian rupee against US dollar closed lower on Friday tracking Asian peers which fall on overnight clue from dollar index where data shows inflation could be sticky. However downside aped by expected funds flow from record high equity market as well into debt and Central bank intervention.

At the NSE Future March 28 contract, the rupee ended weak by 1 paise to closed at 82.90 against the previous close of 82.89 and made low of 82.89 and high of 83.03 during the day. The local unit notched a weekly loss of about 0.1%, its first week-on-week decline since mid-February. Asian currencies weakened, with the Korean won down nearly 0.9% and leading losses.

The U.S. Federal Reserve and Bank of Japan's policy decisions will serve as the key triggers for the rupee next week.

India's foreign exchange reserves rose for a third straight week and reached a more than two-year high of \$636.10 billion as of March 8, data from the central bank showed on Friday.

The dollar rose to a more than one-week high on Friday after a mixed batch of data showed the U.S. economy remained stable with small pockets of weakness, suggesting the Federal Reserve could keep interest rates higher for longer or reduce the planned number of rate cuts this year.

The dollar index, post a weekly gain of 0.7%, The index was last flat at 103.43. The dollar against the yen, up 0.5% at 149.02 and euro at \$1.0889.
